Provided further that the existing teachers who, at the commencement of this Act do not possess minimum qualification shall acquire such minimum qualifications within a period of 5 years of commencement of the Act.
 - vii. The teachers perform their duties specified under section24(1) of the Act and under rule 21.
 - viii. The teachers shall not engage himself or herself in non educational and private teaching activities.
- 6. The school shall follow the syllabus on the basis of curriculum laid down by State Government / educational authority.
